3. **#3 BOATING CUB LAKE:** An ordinance regarding boating on Cub Lake, Bear Lake Township. Boat speed and towing restrictions. 1/12/65
4. **#4 BOATING BEAR LAKE:** An ordinance regarding boating on Bear Lake, Bear Lake Township, Kalkaska County. Boat speed, towing restrictions between 6:30 pm to 10 am the following day. 1/12/65
5. **#3-95 CONSUMERS POWER COMPANY:** An ordinance granting Consumers Power Company ... to do local gas business in the Township of Bear Lake, Kalkaska County, Michigan for a period of thirty years. 7/11/95
6. **#7-97 PARTITIONING OF LAND.** An ordinance to regulate partitioning or division of parcels or tracts of land, enacted pursuant but not limited to Michigan PA 288 of 1967, as amended etc ... 7/1/97
7. **#1-2002 ROAD ENDINGS.** An ordinance to regulate activities on read endings that terminate on the shoreline of lakes and rivers and lake access sites within the Township and to provide penalties for violations of the ordinance. 3/5/02
8. **#5-03 of 2003 BLIGHT ORDINANCE.** An ordinance to protect the public health, safety and general welfare by eliminating blight; to define and prohibit blight; and to provide penalties for violations. 5/13/03
