Township	Board Member Kalkaska Public Schools Partial Term Ending 12/31/2024 Vote for not more than 1	Kalkaska County Kaliseum Millage Renewal Proposal For the sole purpose of renewing funding for the operation and maintenance of the Kaliseum at the same millage level previously approved by the voters in 2008, 2012, and 2016, shall the Constitutional limitation upon the total amount of taxes which may be assessed in one (1) year upon all property within the County of Kalkaska, Michigan, be renewed, and shall the County be authorized to levy, up to 0.250 mill (\$0.25 per \$1,000 of Taxable Value) for a period of four (4) years, 2021 through 2024, inclusive? If approved and levied in full, this millage will raise an estimated \$210,517.50 funding the operation and maintenance of the Kaliseum in the first calendar year of the levy based on taxable value. In accordance with State law, a small portion of the millage may also be disbursed to the Downtown Development Authority of the Village of Kalkaska.
