- 1. Call to Order: Supervisor Banker called the meeting to order at 4:00 PM with four members of the public in attendance.

 - A. Dredge Road End Review: The board reviewed the progress at the road end. Discussing a DNR grant, the board decided not to pursue it.
 - B. Black Bear Rd: The banker gave an update on the petition.

10. New Business

- A. Attorney KMHC Twp's: Amend 1- 2019 Marihuana ordinance, adding a new paragraph in section 1. Additionally, Bear Lake Township further prohibits any marijuana establishments or facilities within its boundaries and declines to grant any licenses under the provisions of the Medical Marihuana Facilities Licensing Act, Act 281 of 2016, MCL 333.27101 et seq. New Ordinance 2-2025: Dannenberg made a motion, supported by Dixon. The roll-call vote was as follows: Banker (yes), Redmond (yes), Dannenberg (yes), Knight (yes), and Dixon (yes). The motion passed. Review of the KMHC attorney.
- B. Interlocal Agreement for Kalkaska County to Approve the Designated Assessor: The Interlocal Agreement for a Designated Assessor for Kalkaska County, January 1, 2026, through December 21, 2029. Kalkaska County proposes that Clifford (Joe) Porterfield serve as the Designated Assessor foe all Townships in Kalkaska County, a motion to approve Clifford (Joe) Porterfield as the Designated Assessor for Bear Lake Township and sign the agreement, Redmond made a motion, supported by Knight, roll -call vote was as followed Banker (yes) Redmond (yes) Dannenberg(yes) Knight (yes) Dixon (yes), motion passed.
- C. Amazon Business Account: The Treasurer has done research and compared pricing. The Treasurer and Clerk discussed establishing a possible Amazon Business Account for Bear Lake Township to save funds on office supplies and other expenses. Dixon made a motion to have the Treasurer and Clerk authorized to open an Amazon Business Account for Bear Lake Township, supported by a roll-call vote, which was as follows: Banker (yes), Redmond (yes), Dannenberg (yes), Knight (yes), and Dixon (yes). Motion passed.

Dornbos Sign Inc.: The Supervisor presented a quote from Dornbos Sign Inc. for 12 signs with our ORV Ordonnance printed on them for each road ends, the cost for 12 signs would be \$ 484.80, Dannenberg made a motion to purchase 12 signs from Dornbos Sign Inc., supported by Redmond, roll- call vote was as followed Banker (yes) Redmond (yes) Dannenberg (yes) Knight (yes) Dixon(yes) motion passed.
